PROCLAMATION OF WINNERS FOR THE 2022 NATIONAL UNIVERSITY - MANILA STUDENT COUNCIL ELECTIONS

In the matter of the canvass and proclamation of the winning candidates for National University Student Government as duly elected officers of the National University Student Council, In connection with the June 8, 9, and 10 university online elections.

WHEREAS, The Commission on Student Election, as a University Board of Canvassers for NUSG and CSC officially canvassed the votes casts for NUSG in connection with the June 8, 9, and 10, 2022 University-wide Elections;

WHEREAS, The Voting was conducted remotely and virtually via Microsoft Forms, and was opened at 8:00am - 3:00pm, and 8:00am - 12:00pm on the date above-mentioned;

WHEREAS, at the end of the online voting, One Thousand Seven hundred thirty-nine (1,739) or eighteen-point forty-six percent (18.46%) out of Nine Thousand Four Hundred twenty-one (9,429) casted their online ballots;
